Gosman and Civil Aviation Safety Authority [2013] AATA 48; 31/1/2013; Deputy President PE Hack SC

Medical certificate — Knowingly or recklessly made false or misleading statement in relation to application for medical certificate — Medical certificate refused — Applicant did not suffer from glaucoma at any time — Use of medication for longer than two consecutive weeks not demonstrated — Applicant failed to disclose sleep apnoea — Sleep apnoea treated successfully — Non-disclosure of sleep apnoea neither knowing nor reckless — Not satisfied applicant knowingly or recklessly made false or misleading statement in relation to application for medical certificate — Decision under review set aside and remitted

Freeman and Fleetmaster Services Pty Ltd [2013] AATA 38; 25/1/2013; Deputy President PE Hack SC

Injury — Failure or refusal to undertake rehabilitation program — Right to compensation suspended — Reasonable excuse — Claimed allocated tasks unsuitable or caused pain — No particular skill required for allocated task — Unreasonable refusal to participate in explanation of allocated task — No contemporaneous complaint of pain — Not satisfied work undertaken caused pain — No explanation for subsequent failure to return to work — No reasonable excuse — Decision under review affirmed

<u>Stefanoski and Telstra Corporation Limited</u> [2013] AATA 50; 1/2/2013; Miss EA Shanahan, Member

Depressive disorder — Anxiety disorder — Panic — Attributed to workplace harassment and bullying — Back pain — Coexisting thyrotoxicosis — Disciplinary action — Reasonable administrative action undertaken in a reasonable manner — Decision under review affirmed

Jurisdiction — Defence force retirement benefits — Applicant resigned from Australian Army — Applicant requested assessment by Chief of Army that applicant could have been retired on grounds of invalidity or of physical or mental incapacity to perform his duties — Chief of Army delegate failed to inform respondent whether such grounds existed — No reviewable decision made by respondent — No jurisdiction

Pensions, benefits and allowances — Disability support pension — Qualification requirements — Residency and medical requirements — Decision under review affirmed

Superannuation — Excess Non-Concessional Contributions Tax — Special circumstances — Discretion under Div 292 — Decision under review set aside

Pensions and benefits — Widow's pension — Death of veteran — Operational service — Ischaemic heart disease — Statement of Principles — Posttraumatic stress disorder factor — DSM-IV-TR Diagnostic Criteria — Four-step procedure for determining whether death was war caused — Reasonable hypothesis connecting death with circumstances of service — Not satisfied beyond reasonable doubt that death was not war caused — Decision under review set aside and substituted

Ockwell and Repatriation Commission [2013] AATA 44; 31/1/2013; Deputy President SD Hotop

Veterans' entitlements — Disability pension — Applicant rendered defence service in Royal Australian Navy from 1968 to 1988 — Applicant performed heavy marine engineering tasks in course of defence service in period 1973-1984 — Applicant suffered osteoarthritis in right wrist in 2008 — Statement of Principles concerning osteoarthritis — Statement of Principles does not uphold contention that applicant's osteoarthritis of right wrist on balance of probabilities connected with defence service — Applicant's osteoarthritis of right wrist not defence-caused — Decision under review affirmed
