AAT Recent Decisions

Compensation

Gibbs and Comcare [2015] AATA 72; 12/2/2015; Deputy President SD Hotop

Commonwealth employees – applicant employed by Australian Taxation Office (ATO) – applicant suffered injury to neck, left shoulder and arm in November 2005 in performance of employment duties at ATO – applicant suffered injury to neck, right shoulder and arm in April 2011 in performance of employment duties at ATO – respondent accepted liability to pay compensation for 2005 injury and 2011 injury – respondent ceased payment of compensation in November 2013 – applicant's pain symptoms in neck, shoulders and arms no longer causally related to compensable injuries – respondent not liable to pay compensation to applicant for compensable injuries since November 2013 – decision under review affirmed

Hoffman and Comcare [2015] AATA 53; 30/1/2015; Deputy President K Bean

Adjustment reaction with mixed emotional features – whether applicant's condition arose as a result of reasonable administrative action taken in a reasonable manner – condition a result of reasonable administrative action taken in a reasonable manner – decision under review affirmed

Education and Research

<u>Hewawasam Revulge and Secretary, Department of Education</u> [2015] AATA 70; 10/2/2015; Ms R Perton, Member

HIGHER EDUCATION – student enrolled for post graduate course – request for leave of absence for semester – application deemed lodged after census date – leave of absence granted – fees imposed – whether grounds to re-credit entitlements – special circumstances – Ministerial guidelines – decision affirmed

Immigration and Citizenship

GJRL and Minister for Immigration and Border Protection [2015] AATA 76; 13/2/2015; Senior Member J Handley

Application for citizenship by conferral – finding that applicant was not of good character – applicant arrived in Australia aged 5 and now 35 years – offended on multiple occasions and annually between 1995 and 2003 and again in 2007 – offending first occurred as a teenager – section 501 notice in 2004 was not contested – applicant lawfully returned to Australia in 2005 – subsequently married, became a father, obtained secure employment with substantial salary – strong supportive family network – forensic psychologist found the applicant at low risk of recidivism – decision set aside

<u>Kim and Minister for Immigration and Border Protection</u> [2015] AATA 67; 9/2/2015; Deputy President JW Constance

Citizenship by conferral – residence requirement – consideration of discretion in section 22(9) – whether the Applicant had a close and continuing association with Australia during periods of absence – decision affirmed

Shekarchian and Minister for Immigration and Border Protection [2015] AATA 68; 9/2/2015; Deputy President JW Constance

Citizenship by conferral – good character – whether the applicant satisfies the legislative requirement to be shown to be of good character – previous convictions – decision affirmed

YVWV and Minister for Immigration and Border Protection [2015] AATA 66; 9/2/2015; Deputy President JW Constance

Refugees – protection visa – whether protection obligations to applicant – whether serious reasons for considering that applicant had committed a serious non-political crime prior to admission – decision set aside and remitted

Social Security

Disability Support Pension - participation in a program of support - decision affirmed

<u>Frenzel and Secretary, Department of Social Services</u> [2015] AATA 71; 11/2/2015; Senior Member AC Cotter

Age Pension – whether Australian resident for purposes of pension payment – extended periods living outside Australia – decision under review affirmed

Khdher and Secretary, Department of Social Services [2015] AATA 74; 13/2/2015; Professor R McCallum AO, Member

Pensions – disability support pension – whether the applicant's impairment is of 20 points or more under the Impairment Tables – decision affirmed

Whitham and Secretary, Department of Social Services [2015] AATA 9; 12/1/2015; Miss EA Shanahan, Member

Pensions benefits allowances – disability support pension claim – conditions of chronic fatigue syndrome, post-traumatic stress disorder, depression and chronic obstructive pulmonary disease – no condition fully diagnosed, treated and stabilised – no impairment rating attracted – decision affirmed

YKBJ and Secretary, Department of Social Services [2015] AATA 65; 4/2/2015; Senior Member CR Walsh

Overpayment of parenting payment, family tax benefit and childcare benefit – overpayments debts due to Commonwealth – write-off of debts inappropriate – debts not attributable solely to administrative error made by Centrelink – no "special circumstances" warranting waiver of debts – decision under review affirmed

Taxation

Wu and Commissioner of Taxation [2015] AATA 78; 13/2/2015; Deputy President PD Hack SC

Assessable income – whether assessments were excessive – whether income derived from overseas interests – decision set aside – remitted for reconsideration

Shortfall penalty – recklessness – statements false or misleading in a material particular – shortfall penalty affirmed
