Eligibility – whether applicant satisfied the awareness, English and knowledge criteria for Australian citizenship – whether the applicant was suffering from a permanent or enduring physical or mental incapacity – Tribunal not satisfied that applicant's limited English language abilities a result of mental incapacity – decision under review affirmed

Whether Tribunal satisfied that the applicant is of good character – multiple traffic offences – drug offence – failure to provide candid responses in citizenship application form – decision affirmed

Whether injury or aggravation of injury in relevant period – decision affirmed

Student (Temporary) (Class TU) visa Subclass 572 – cl 572.223 – Whether genuine intention to stay in Australia temporarily – Applicant undertook a series of unrelated courses – Limited ties to Korea – Plans to settle in Australia – Using student visa program to remain in Australia – Decision under review affirmed

Visitor (Class FA) visa – Japan – Subclass 600 (Visitor) – cl 600.211 – Whether applicant intends to stay temporarily – Limited ties and incentive to return to Japan – Moved his belongings to Australia – Seeking an alternative life in Australia – Previously held Student and Visitor visas – Lack of funds – May work or study in breach of visa conditions – Decision under review affirmed

Cancellation – Subclass 100 (Spouse) visa – s 101(b) – provision of incorrect information in application –Sponsor and applicant relationship has ended – Decision under review affirmed

Regional Employer Nomination (Permanent) (Class RN) visa – Subclass 187 (Regional Sponsored Migration Scheme) – cl 187.233 – No approved nomination – Nominator employer did not appear for scheduled review hearing – Nominator refusal matter finalised prior to hearing of visa application – Decision under review affirmed

Child (Migrant) (Class AH) visa – Subclass 101 (Child) – cl 101.213 – cl 101.221 – Whether applicant undertook full-time study at educational institution leading to award of professional, trade or vocational qualification – Delegate's definition of educational institution restrictive according to departmental policy – Continuous full-time study after completing year 12 – Institution awards diplomas and certificates – Decision under review remitted

Protection visa – Tonga – Fears harm by relative – Threats from rival gangs and criminals – Credibility issues – Decision under review affirmed

Protection visa – China – Religion – Shouters – Committed and active members of the Local Church – Church considered an evil cult – Imprisonment of family and church members – Decision under review remitted

1501250 (Refugee) [2016] AATA 3323 (16 February 2016); T Caravella, Member

Protection visa – China – Complementary protection provisions – Religion – Christianity – Catholic – Property dispute – Credibility issues – Inconsistent and fabricated evidence – Unlawful in Australia for many years – Decision under review affirmed

Protection visa – Pakistan – Imputed political opinion – Refused to help Taliban – Refusal to recruit young men to join Taliban – Credibility issues – Numerous trips to and from Pakistan without experiencing harm – Delay in applying for protection – Decision under review affirmed

1417195 (Refugee) [2016] AATA 3325 (19 February 2016); T Flood, Member

Protection visa – Bangladesh – Political opinion – Extortion attempts by opposition party members – Animosity from other shop owners – Falsely accused of murder – Credibility issues – Decision under review affirmed

Practice and Procedure

Coombs and Hartwig Air Group Pty Ltd [2016] AATA 137 (15 February 2016); Deputy President K Bean

Jurisdiction – Request for re-crediting of VET FEE-HELP balance on the grounds of "special circumstances" – Where VET provider's decision has not been reconsidered by the Secretary – No jurisdiction – Further request for re-crediting on the basis that the VET provider ceased to provide the course – No decision made by VET provider – Enactment does not confer jurisdiction on Tribunal to review decisions of that kind – Application dismissed

<u>Dr Ageless Pty Ltd and Commissioner of Taxation</u> (Taxation) [2016] AATA 136 (8 March 2016); Deputy President SA Forgie

Fees – reduced fee – corporate applicant requested fee reduction on basis of financial hardship – request on basis of financial hardship not restricted to applicants who are individuals – request for reduction refused – no application for review of decision

Dismissal – prescribed fee not paid on lodgement or subsequently – request for reduced fee on basis of concessional circumstances refused – opportunity to provide further information to support request for reduced fee – further information provided relating to garnishee notice but not to financial circumstances – prescribed fee not paid – appropriate opportunity given to pay prescribed fee or provide further information – application dismissed

Mitchell and Comcare (Compensation) [2016] AATA 141 (11 March 2016); Deputy President SA Forgie

Conditional withdrawal – nature of withdrawal – whether conditional withdrawal constitutes a withdrawal – power of Tribunal to consider substantive issues without a hearing – failure of applicant to proceed with application or comply with direction within reasonable time – application dismissed

Fletcher and Secretary, Department of Social Services (Social services second review) [2016] AATA 140 (9 March 2016); Senior Member AC Cotter

Disability support pension – DSP – whether 20 points or more under the impairment tables during the relevant period – whether conditions are fully diagnosed, treated and stabilised – value of medical evidence – whether continuing inability to work – decision under review affirmed

<u>Foote and Secretary, Department of Social Services</u> (Social services second review) [2016] AATA 131 (4 March 2016); Deputy President K Bean

Disability support pension – whether applicant's conditions fully diagnosed, treated and stabilised – Rateable impairments do not attract 20 points under Impairment Tables – decision under review affirmed

Ryan and Secretary, Department of Social Services (Social services second review) [2016] AATA 132 (4 March 2016); Mr C Ermert, Member

Disability Support Pension – qualification period – physical, intellectual or psychiatric impairments – whether impairments attracted a rating of 20 points or more – decision affirmed

<u>Tamay and Secretary, Department of Social Services</u> (Social services second review) [2016] AATA 142 (11 March 2016); Mr C Ermert, Member

Disability Support Pension – unlimited portability – severe impairment – 20 impairment points under a single table – decision affirmed

<u>Zubac and Secretary, Department of Social Services</u> (Social services second review) [2016] AATA 134 (7 March 2016); Dr I Alexander, Member

Disability support pension – whether conditions fully diagnosed, treated and stabilised – impairment ratings – continuing inability to work – "severe impairment" during claim period – lumbar spine condition – knee condition – chronic post-traumatic stress disorder – alcoholism – decision affirmed
