AAT Recent Decisions

This section of the Bulletin provides information about all decisions recently published in the AAT's General, Freedom of Information, National Disability Insurance Scheme, Security, Taxation & Commercial and Veterans' Appeals Divisions as well as about select decisions recently published in the Migration & Refugee Division. Citizenship

<u>Vizman and Minister for Immigration and Border Protection</u> (Citizenship) [2016] AATA 328 (20 May 2016); Deputy President Dr C Kendall

Whether citizenship should be conferred – applicant aged 4 was born in Australia and has permanent residency – Applicant now residing with mother in Israel but spends considerable amount of time with father both in and outside of Australia – Applicant satisfied citizenship requirements but Department denied Applicant citizenship on basis that he was not living with father who was an Australian citizen – whether, as per Australian Citizenship Instructions, it can be found that Applicant "living with a responsible adult who is an Australian citizen" and/or whether citizenship "in best interest of the child" – decision set aside and remitted with a direction that citizenship be approved

Compensation

Applicant and Australian Offshore Solutions Pty Ltd (Compensation) [2016] AATA 331 (20 May 2016); Senior Member CR Walsh and Brigadier AG Warner, Member

Claim for seafarers compensation – whether claimed injury (stress and digestive disruption) arose out of applicant's employment as an Integrated Rating with the respondent – whether sign-off incident on board the vessel caused the claimed injury – no causal connection between alleged injury and the applicant's employment with the respondent – decision under review affirmed

<u>Sastre and Military Rehabilitation and Compensation Commission</u> (Compensation) [2016] AATA 335 (24 May 2016); Deputy President B McCabe

Liability claim for psychiatric condition – whether applicant suffered from adjustment disorder – whether related to employment in the military – Tribunal cannot be satisfied alleged events contributed to the applicant's condition – decision under review affirmed

Corporations

<u>Chong and Australian Securities and Investments Commission</u> [2016] AATA 338 (26 May 2016); Senior Member CR Walsh

Decision by Australian Securities and Investments Commission to make banning order prohibiting applicant from providing "financial services" for five years – whether power to impose a banning order enlivened – whether banning order should be imposed in the applicant's case – period of banning order – decision under review affirmed

Exemption – legal professional privilege – in-house agency legal services division – whether appropriately independent of remainder of agency – whether communications between legal services division and another division within the agency – made for the dominant purpose of giving or obtaining legal advice – whether waiver of privilege – decision varied

Request for access to documents relating to Australian Federal Police Professional Standards Investigation – whether documents conditionally exempt from disclosure – whether disclosure would have substantial adverse effect on the proper and efficient conduct of the operations of the agency – whether disclosure would be contrary to the public interest – decision under review affirmed

<u>Leigh and Australian Federal Police</u> (Freedom of information) [2016] AATA 330 (20 May 2016); Senior Member Dr J Popple

Request for access to names of former staff of the Minister for Foreign Affairs contained in Australian Federal Police report – whether staff names are conditionally exempt from disclosure – whether disclosure would involve unreasonable disclosure of personal information – whether disclosure would be contrary to the public interest – decision varied

Whether applicant can rely on Parliamentary proceedings and media references to Parliamentary proceedings – whether reliance on material would invite the drawing of inferences or conclusions contrary to s 16(3)(c) of the *Parliamentary Privileges Act 1987* – applicant cannot rely on material

Bridging visa – s 501 discretion to refuse visa application – where applicant convicted of fraud – character test – whether primary considerations weigh against applicant – discretion should be exercised against the applicant – decision under review affirmed

Visitor (Class FA) visa – Japan – Subclass 600 (Visitor) – cl 600.215(b) – Exceptional circumstances for stay of more than 12 consecutive months – Wife is seasonal worker – To be in an English-speaking environment – Studying snails and their impact on viticulture – Not formal study or research – No hardship on wife's employer – Only chance to tour Australia with wife – Decision under review affirmed

Cancellation – TU Student (Temporary) – 573 Higher Education Sector – s 116(1)(a) – Fact or circumstances for the grant of the visa no longer exists – Separated from primary visa applicant – Vague and unformulated plans for future – Decision under review affirmed

Protection visa – Albania – Bogus documents – s 91WA – Fraudulently altered passport – Applied for various Australian onshore visas – Purchased Australian driver's licence in another identity – False and misleading statements – No reasonable explanation for bogus documents or delay in protection application – Decision under review affirmed

1314887 (Refugee) [2016] AATA 3766 (23 April 2016); G Haddad, Senior Member

Protection visa – Sri Lanka – Political – Supporter of UNP – Social group – Failed asylum seeker – Participated in political activities – Experienced economic problems – Father and brother suffered mistreatment – Not a high profile person and of no interest to authorities – Short term detention on return not persecution – Decision under review affirmed

1500142 (Refugee) [2016] AATA 3781 (27 April 2016); A Younes, Senior Member

Protection visa – Mexico – Particular social group – Wealthy middle class family – Sur place events – Violent crime – Drug cartels – Family subjected to incidents of harm – Authorities implicated in human rights abuses – Internal relocation unreasonable – Decision under review remitted

1418066 (Refugee) [2016] AATA 3805 (28 April 2016); R Shanahan, Member

Protection visa – Jordan – Forced marriage – Forced conversion to Islam – Assaulted and detained for a lengthy period – Credibility issues – Decision under review affirmed

1603711 (Refugee) [2016] AATA 3793 (28 April 2016); D Corrigan, Member

Protection visa – Iraq – Political opinion – Former member of Iraqi military – Religion – Christian – Argument with powerful senior militia member – Continued threats to kill applicant – Fears harm from military for deserting his post – Abandoned Islam and converted to Christianity – Fear of reprisals for becoming an apostate – Decision under review remitted

1413076 (Refugee) [2016] AATA 3769 (2 May 2016); M Moustafine, Member

Protection visa – Nepal – Social group – Unmarried women – Claims will be forced into an arranged marriage – Credibility – Inconsistent and contradictory evidence – Decision under review affirmed

Protection visa – Lebanon – Political opinion – Low level supporter of Future Movement – Participated in anti-Syria and Hezbollah demonstrations – Detained and mistreated for some hours – Conceded to have been in the wrong place at the wrong time – Remained for 3 years after the incident – Delay in departing Lebanon and applying for protection – General security situation not faced by applicant – Decision under review affirmed

Protection visa – Ukraine – Religion – Christian – Political opinion – Opposed to war and general civil unrest in Ukraine – Economic difficulties – War not within applicant's home region – Applicant returned to Ukraine – Request for withdrawal of application not accepted – Decision under review affirmed

Age pension entitlement – extent to which issue estoppel applies – no application made under s 42B – previous decision by consent – whether applicant entitled to age pension – decision under review affirmed

Claim for disability support pension – meningioma at skull base involving middle cranial fossa and compressing optic nerve, bone and veins – loss of vision left eye – loss hearing and balance left ear – tumour not resectable – treatment aimed at debulking – impairment rating increased to 20 points – program of support not completed – decision that not qualified for DSP affirmed

Disability support pension – whether applicant has 20 impairment points under one table – whether applicant has continuing inability to work – applicant has 25 points under multiple tables – applicant has continuing inability to work – decision under review set aside
