Accepted condition – whether condition contributed to by employment – Applicant employed in Centrelink call centre – contemporaneous medical evidence attributes condition to alternate employment – condition not contributed to in a significant degree by applicant's employment – decision under review affirmed

APPLICATION FOR DISMISSAL – Application frivolous or vexatious – Applicant's entitlement to Austudy paid at the higher rate – failure to meet statutory criteria – no jurisdiction to decide claims of misleading or deceptive conduct – natural justice – role of the Tribunal conducting merits review – application dismissed

Overpayment of Newstart allowance – recovery – alleged administrative error giving rise to overpayment – applicant's evidence of bona fide disclosure of earnings not accepted – no administrative error found – decision affirmed

Disability support pension – anxiety and depression – osteoarthritis in both knees – gastric reflux – morbid obesity – hyperlipidaemia – spinal stenosis – whether conditions fully diagnosed treated and stabilised – impairment ratings – program of support – decision under review affirmed

Misrachi and Secretary, Department of Social Services [2014] AATA 727; 7/10/2014; Senior Member AF Cunningham

Parental leave pay – work test – adopted child – no referable provision in Act to accommodate applicant's circumstances – decision under review affirmed

Rainsford and Secretary, Department of Social Services [2014] AATA 735; 10/10/2014; Mr M Hyman, Member

FAMILY ASSISTANCE – family tax benefit – child born overseas – determination of rate of benefit - where recipient spent an extended period overseas – operation of discretion to extend portability – whether recipient involved in custody proceedings – whether proceedings were in Fiji - whether unable to travel – whether proceedings occurred or began in the initial period of absence – decision set aside and substituted

Disability Support Pension – unlimited portability – severe impairment – inability to work independently of program of support – decision set aside and substituted

Assessable income – Capital Gains Tax – eligible termination payments – disposal of a CGT asset – ETP Liability – maximum net asset value test – small business CGT affiliate – assets used solely for personal use and enjoyment – capital proceeds from a CGT event – penalties – failure to take reasonable care – reasonably arguable position – sale of shares – company resolution – contract – goodwill – loans – decision under review affirmed

Veterans' Affairs

<u>Dawes and Repatriation Commission</u> [2014] AATA 730; 9/10/2014; Brigadier C Ermert (Rtd), Member

Veteran not yet turned 65 – veteran is totally and permanently incapacitated – incapacity from war-caused injuries alone – prevented from continuing to undertake remunerative work – suffering a loss of salary – decision set aside and substituted

<u>Lipke and Repatriation Commission</u> [2014] AATA 729; 8/10/2014; Dr M Denovan, Member

Benefits and entitlements – eligibility for pension – rhabdomyosarcoma inability to obtain appropriate clinical management – whether these is material contribution to a condition – whether there is aggravation of a condition – no connection between eligible defence service and condition – not entitled to any benefits – decision affirmed
