Military Compensation – where Applicant suffers from ulcerative colitis – irritable bowel syndrome – whether condition connected to military service – statement of principles concerning inflammatory bowel disease – whether Applicant was using non-steroidal anti-inflammatory drugs before clinical onset of IBD – decision under review affirmed

Rejection of claim for disability support pension – physical impairments – most appropriate Impairment Table for assessment of impairment rating – whether applicant's impairment rating is of 20 points or more under the Impairment Tables – whether neurological or cognitive function impairment – decision under review affirmed

<u>Thompson and Secretary, Department of Social Services</u> (Social services second review) [2017] AATA 1638 (7 September 2017); Mrs JC Kelly, Senior Member

Age Pension – applicant's Age Pension from 10 July to 30 June based on incorrect superannuation calculation – should applicant be paid in arrears for the Age Pension based on correct superannuation calculation – section 109 of the Social Security (Administration) Act 1999 does not allow for this – decision under review affirmed

Ham and Tax Practitioners Board (Taxation) [2017] AATA 1642 (9 October 2017); Senior Member AC Cotter

TAX AGENTS – application for renewal – whether Applicant was a fit and proper person – where Applicant had been found liable for breach of trust – where Applicant had been found liable for breach of fiduciary duties – use of Supreme Court of Queensland findings – whether Applicant had shown contrition – where Applicant initially failed to disclose potential issues – decision under review affirmed

VETERANS' AFFAIRS – veteran deceased – cause of death prostate cancer – claim for pension by widow – relevant Statement of Principles – standard of proof ss 120(1), 120(3) and 120A of the Act – whether death related to operational service – whether there is a reasonable hypothesis supported by the relevant SoP – Deledio steps – factors of the SoP that as a minimum must exist are not satisfied – reasonable hypothesis not raised connecting the death of veteran with his service – widow not entitled to pension – decision under review affirmed

# Jurisdiction and legislative changes

This section of the Bulletin provides a summary of significant legislative changes that affect the AAT, including changes and potential changes to the AAT's jurisdiction to review decisions. Information about the AAT's jurisdiction can also be found on the AAT website.

### Safety, Rehabilitation and Compensation Legislation Amendment (Defence Force) Act 2017

On 12 October 2017, the Safety, Rehabilitation and Compensation Legislation Amendment (Defence Force) Act 2017 (Amendment Act) commenced.

Among other things, the Amendment Act has created a new standalone Act, the Safety, Rehabilitation and Compensation (Defence-related Claims) Act 1988 (SRC (DRC) Act), which is a re-enactment of the Safety, Rehabilitation and Compensation Act 1988 (SRC Act), with modification, to cover Australian Defence Force (ADF) members. Broadly, the SRC (DRC) Act applies in relation to injury, disease or death relating to ADF employment that occurred from commencement of the SRC Act in 1988 to commencement on 1 July 2004 of the Military Rehabilitation and Compensation Act 2004.

The Amendment Act has also amended the SRC Act to remove ADF members from the scope of that Act.

The amendments affect SRC Act applications involving ADF members that were:

- before the Tribunal but not finalised by 12 October 2017, or
- lodged with the Tribunal on or after 12 October 2017.
