Cancellation of flight crew licences – Incidents occurred during filming of television series – Duty with respect to the safe navigation and operation of an aircraft – Fit and proper person – Discretion to vary, suspend or cancel – Cancellation not appropriate – Decision under review set aside and substituted – Flight crew licences suspended until applicant obtains further certification to acquire necessary knowledge and decision-making skills for those licences
