Medical treatment – ongoing massage therapy – whether treatment was reasonable for the employee to obtain – decision set aside and substituted

Injury or disease – ailment or aggravation of ailment – contributed to by employment to a significant degree – decision set aside and a decision made in substitution

Tariff classification – whether or not subject goods are disinfectants – identification of essential character of goods – application of Harmonized Commodity Description and Coding System Explanatory Notes – chemical properties of subject goods – where subject goods alter processed meats to make environment less conducive to bacterial reproduction – appropriate classification of goods as food preservatives – decision set aside

Visa refusal – application for sponsor visa – failure to pass character test – criminal record – dangerous driving causing death – 18 month suspended sentence – high degree of moral culpability not present – discretion to refuse applicant's visa – Ministerial Direction no. 65 applied – protection of the Australian community – seriousness and nature of the relevant conduct – the risk conduct may be repeated – expectations of Australian community – family of victim of applicant's criminal conduct, impact on – decision under review set aside

Good character – enduring moral qualities – whether Applicant honest and financially responsible – whether Applicant has been untruthful and practised deception or fraud in dealings with Australian government – mitigating factors – decision set aside and substituted

Licensing – mutual recognition – ACT contractor licence – NSW contractor licence refused – directors duties – whether the applicant took all reasonable steps to avoid liquidation – whether the applicant is a fit and proper person – whether non-disclosure on application was deliberate – risk to the public – decision affirmed

Disability Support Pension – relevant period – whether physical, intellectual or psychiatric impairment – whether conditions fully diagnosed, fully treated and fully stabilised, corroboration of self–report of symptoms – whether impairment rates 20 points under Impairment Tables – decision affirmed

Pensions, benefits, allowances – payment of Newstart allowance – assets test – loan to family trust – where applicant's loan to family trust an asset which exceeded assets value limit – asset hardship provisions – loan to family trust an unrealisable asset – where available funds exceeded annual maximum rate of newstart allowance – whether proceeds of loan drawdowns available to applicant – where applicant had capacity to access funds and/or remove trustee in his role as appointer – no severe financial hardship – decision affirmed
