Recent developments

New Small Business Taxation Division to commence on 1 March 2019

On 1 March 2019, a new Small Business Taxation Division will commence within the AAT, as [announced by](#) the Assistant Treasurer, the Hon. Stuart Robert MP.

The new Division is part of a range of measures announced to make it simpler for small businesses to resolve tax disputes. Other measures include a Concierge Service delivered by the Australian Small Business and Family Enterprise Ombudsman (ASBFEO).

Applicants to the AAT's new Small Business Taxation Division will pay a reduced application fee, have a case manager, early case assessment, and an expedited turnaround time for decisions, with AAT decisions in most cases being made within 28 days of the last day of the hearing, or receipt of further permitted evidence or submissions.

Additionally, under a scheme administered by the ASBFEO, unrepresented small business taxpayers who apply to the AAT's new Small Business Taxation Division may be able to access one hour of free legal advice.

The AAT is currently seeking feedback on two documents on the proposed operations of the new Division:

1. a Practice Direction titled [Review of Small Business Taxation Decisions](#), and
2. a [Guide to Small Business Taxation Division](#).
